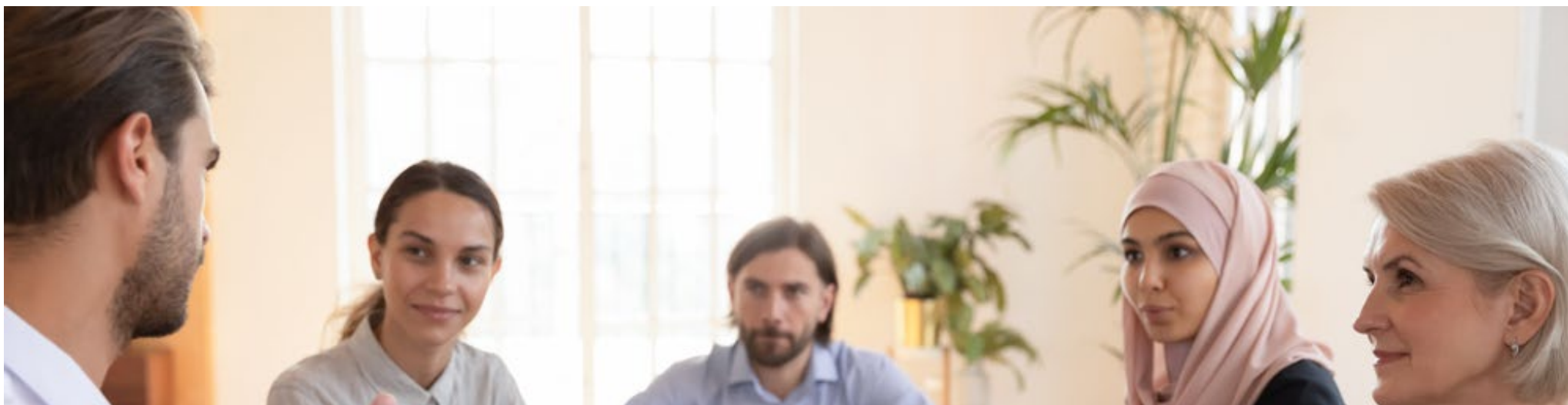

Please be advised that you cannot book for an assessment if you haven't booked/completed the prerequisite course. The assessment fee is not included in the course fee, it must be registered and paid for separately.

Assessments are completed via LearnADR, Ciarb's online learning platform which are centrally assessed by HQ. Candidates will be given 48 consecutive hours within a 5-day window starting from the centralised assessment start date to submit their answers online. Results are dispatched to candidates approximately twelve weeks from the 5th day of the assessment submission window. Candidates will be informed of any delays.

*Module 2 - Law of Obligations is the same as Module 2 under all ADR Pathways.

**Module 1 Mediation Assessment fee is included in the course fee unless candidates are taking the assessment only.
