Applicants must demonstrate the following:

A knowledge of law of obligations and evidence at first degree level or recognised equivalent or an understanding of law relevant to your mediation practice or recognised equivalent.

A minimum of 10 years' experience in arbitration or construction adjudication, or mediation (in a lead/sole mediator capacity) including settlement agreements, the management of proceedings and attending hearings which have resulted in the publication of a reasoned award or decision.

Experience of writing directions and final, reasoned awards or decisions/experience of writing Mediation Agreements/ Heads of Agreements/ Memoranda of Understanding.

A schedule of appointments undertaken in the last 10 years, indicating in which capacity i.e. sole arbitrator, tribunal member, counsel, sole mediator or where you have co-mediated as the lead mediator.

Applicants must also provide the names of two CI Arb Fellows or Fellows (or equivalent grade) (i.e. Mediation - Supervisor or Professional Practice Consultant) from other accrediting or appointing bodies from whom references will be sought.

These should be individuals who have first hand experience of you in the role of dispute resolver, party representative or Mediator in an Arbitration, Mediation or Adjudication. These may be individuals who have appeared before you whilst acting as a dispute resolver party representative or Mediator.
