

Dyalá Jiménez is a Costa Rican national and specializes in international arbitration. She is frequently appointed as arbitrator in institutional and ad hoc arbitrations, both in commercial disputes and disputes between investors and States. She is a member of the ICSID panel of conciliators and arbitrators for Costa Rica.

Dyalá worked at the International Chamber of Commerce for seven years. She also worked in two law firms in Santiago de Chile and, in 2011, she founded DJ Arbitraje. She is the author of numerous publications and has been a professor at the Lead University in Costa Rica, the University of Chile and the LLM Program of Heidelberg / University of Chile.

Dyalá is a founding member of the ICC Latin American Arbitration Group, the International Arbitration Institute (IAI) and the Latin American Arbitration Association (ALARB). She served as co-editor-in-chief of the ICC Newsletter and Vice-President of the ICC ADR and Arbitration Commission.

Dyalá served as Minister of Foreign Trade of the Republic of Costa Rica from July 2018 to August 2020.
