Speakers profile:

Robert G Volterra

Partner at Volterra Fietta and Visiting Professor of Law at University College London

Professor Volterra advises and represents governments, international organisations and private clients on the full spectrum of public international law issues. He acts as counsel and advocate in international disputes around the world, including cases before the International Court of Justice, Permanent Court of Arbitration tribunals and investor-State arbitration tribunals.

In relation to BIT arbitrations, Robert has advised and represented parties in BIT cases for thirty years. He acts for both investors and governments in equal measure. He is also regularly appointed by both investors and governments to sit as an arbitrator at ICSID, the PCA and other major international arbitration institutions. Robert's cases as counsel and arbitrator are amongst the best-known BIT awards, taught in classrooms around the world and relied upon as precedents by other lawyers, courts and tribunals.

The global legal directories have ranked Professor Volterra and his practice consistently in the top tier, since they began raking practices more than 25 years ago. In its 2022 edition, Chambers and Partners stated: "Robert Volterra is probably the best public international lawyer on the planet" and Legal Business called him "[A] star of international investment treaty arbitration."

Professor Martins Paparinskis

Professor of Public International Law at University College London

Professor Martins Paparinskis is a Professor of Public International Law at University College London. He is a public international lawyer with a variety of specialisms, including international investment law and international dispute settlement. Martins has published widely, including in leading journals, such as the American Journal of International Law, British Year Book of International Law, Journal of International Dispute Settlement, Journal of World Investment and Trade, and ICSID Review—Foreign Investment Law Journal.

His work is regularly cited on issues of international law by domestic courts and international tribunals, e.g., recently in Vento Motorcycles, Inc v Mexico; OOO Manolium Processing v Belarus; Lion Mexico Consolidated v Mexico; Westbridge Ventures II Investment Holdings v Anupam Mittal; Trustees for the time being of Burmilla Trust and Another v President of RSA and Another; Gramercy Funds Management LLC and Or v Peru.

Martins is recognised by his peers in the field of public international law and particularly investment law. He is a member of the United Nations International Law Commission (2023-), a member of the Permanent Court of Arbitration (since 2017) and a conciliator of the OSCE Court of Conciliation and Arbitration (since 2019). In the field of investment law, Martins is a member of the ICSID Panels of Arbitrators and of Conciliators, a member of the Beijing Arbitration Commission / Beijing International Arbitration Center's Panel of Arbitrators for International Investment Arbitration, and a member of CIETAC (China International Economic and Trade Arbitration Commission) Panel of Arbitrators. Martins is an editor of the Journal of World Investment and Trade and of the Journal of International Economic Law.
