

# Diploma structure

This Diploma follows the international maritime arbitral process from beginning to end. Candidates will be involved in interactive sessions from day one.

## Typical day

### Session 1:

Commencement of ad hoc arbitration.

### Session 2:

Cargo claims, bills of lading and maritime arbitration.

### Session 3:

Arbitration in shipbuilding disputes.


### Session 4:

Conflicts and Code of Conduct.

### Session 5:

Problem-based interactive workshop.





# Assessment structure

## **Part 1 Law, Practice and Procedure of International Maritime Arbitration**

Candidates will have 48 hours to submit an assessment.

The first part of the assessment is a case study with questions. This is worth 40% of the overall mark.

In the second part of the assessment, candidates choose three questions to answer from a selection of five questions. This is worth 60% of the overall mark.

Candidates need to obtain 65% to pass.

## **Part 2 Law of Obligations**

Candidates must demonstrate expertise in common law and civil law of contract tort.

Candidates with a recognised law degree are eligible for the exemption test, otherwise they must complete and successfully pass Module 2.

Candidates complete a 90-minute test which comprises 30 questions, and must obtain 70% to pass.

The exemption test needs to be completed by 10 August 2026. Ciarb Fellows do not need to complete the exemption test.

## **Part 3 Evidence and Award Writing of International Maritime Arbitration**

Candidates are required to submit an award.

The assessment is split into two stages.

### **Stage one:**

The documents in the case are released on 11 August 2026 and the assessment begins on 21 August 2026.

The papers are sufficient to allow candidates to grasp the nature of the case and the likely legal problems.

Candidates should consider the recitals they intend to include and the relevant law.

### **Stage two:**


This is the equivalent of the hearing stage. It includes an extract from the candidate's (arbitrator's) notebook. This records the oral evidence and arguments the arbitrator has heard, as well as any other relevant documents.

From the evidence, candidates must make their findings of fact. Different candidates will make different findings.

Stage two is released at 12:00 GMT +1 on 21 August 2026.

It is available for five days. Candidates have 48 consecutive hours within these five days to submit their award. Results will be released 12 weeks after the deadline.





# Entry requirements

To successfully enrol on this Diploma, you must demonstrate one of the following:

- You are actively involved in, or have experience of, domestic or international arbitration
- You have at least five years' professional experience in a related field

Additionally, you must have a high standard of English.

# Diploma fee

The full fee is £5,995.00, including VAT. When booking early, members will pay £5,225 and non-members £5,500.

50% of the full fee must be paid as a deposit on registering. This is non-refundable.




